# Motion 1: Update Policy in ARTICLE X to state that the Vice Chairperson has a vote within the subcommittee:

"Each member has the equal right of input and vote in the committee except for the Chairperson. In the event of a tie vote by this committee, the Chairperson breaks the tie."

Motion 2: Update Policy in ARTICLE XII to remove the one-year term limit on Panel Leaders and Coordinators that was created in 2016 and change the policy back to how it was previously followed which will allow Panel Leaders and Coordinators to continue their commitments after serving the minimum one year term.

"Panel Coordinators and Panel Leader Qualifications:

Elected by majority vote of this H&I subcommittee for a **minimum** of a one-year term. They can continue the commitment past a year until such a time where they would like to give someone else the opportunity or they can no longer continue to make the commitment."

Intent: To eliminate purposely creating vacancies at facilities when there are people willing and able to continue their commitments.
