Motion 1: To change H & I policy Article II Purpose Remove the words "Full Access" To "Regular NA Meeting" Intent: So H & I can continue to carry the message into outpatient facilities.

Region Motions:

Motion 2: Any Subcommittee email addresses will use the @tsrscna.org GoDaddy email. **Intent:** Accountability to the region.

Motion 3: All merchandise remaining at the end of both Start to Live and Spiritual Retreat must be returned to the B.O.D

Intent: Stay accountable with STL and SR merchandise.

Motion 4: To amend Start to Live policy amendment dated February 2015 as follows: to change it from "All bid for any events (STL SR) weekend must be received by the negotiating team 90 days prior to the event..." from 90 days to 60 days.
